IN 2022, PPF EXPANDED ITS SMALL GRANTS PROGRAM PROGRAM TO SUPPORT 25 LOCAL FRIEND GROUPS AND PARTNER ORGANIZATIONS PROMOTING EQUITABLE ACCESS TO PARKS, NATURAL AREAS, COMMUNITY GARDENS AND COMMUNITY CENTERS (\$49,000 TOTAL AWARDED). PPF ALSO CELEBRATED VOLUNTEERISM THROUGH OUR PARKS CHAMPION AWARDS AND LAUNCHED A NEW EMERGING LEADER AWARD, THE JOEY POPE AWARD FOR PARKS LEADERSHIP.
